## ONLINE PRIVACY POLICY

We want you to understand what personally identifiable information we collect from you when you use or visit our websites, [www.Wedbush.com](http://www.Wedbush.com), [www.WedbushFutures.com](http://www.WedbushFutures.com), or [www.KluisCommodities.com](http://www.KluisCommodities.com). In this Online Privacy Policy, “we,” “us,” and “our” refer to Wedbush Securities Inc.; Wedbush Securities Advanced Clearing Services; Wedbush Futures; and Wedbush & Co., LLC; Wedbush Financial Services, LLC; Wedbush Capital Management, LLC; and Kluis Commodity Advisors (collectively, “Wedbush”). “You” refers to you, an individual.

### **Personal Information We Collect When You Visit Our Websites**

- Identifiers, such as your Internet Protocol (IP) address, device identifier, and the URL you came from before you visited our website.
- Information regarding your interaction with our website, including time spent, and engagement with our website and the content on the website.
- Information such as your name, email address and telephone number that you voluntarily provide to us through the “Contact Us” interactive web form on our website.
- Information such as your name, title, company name, email address, telephone number and address when you sign up to receive the Wedbush Bulletin.
- Information that you email to us.
- When you log into your Wedbush Securities account through our ClientLink Login portal or when you log into your Wedbush Futures account through our Wedbush Futures portal, we collect your user name and password, along with any additional information that you provide to us while you are logged on to ClientLink. We also collect information about your activities while you are logged into your account.
- Kluis Commodity Advisors is a trade name used by the Wedbush Futures division of Wedbush Securities Inc. In addition to the foregoing, when you visit [www.KluisCommodities.com](http://www.KluisCommodities.com), you also have the ability to open a trading account online and to log into your trading account. If you open a trading account, we will collect your first and last name, user name, e-mail, physical address, telephone number, tax identification number and other information from you. We also collect information about your activities while you are logged into your trading account.

### **Information We Share With Third Parties**

We share your IP address, the URL you came from, and your interaction with the website with analytics providers, third-party advertising networks, and social media platforms for their use in

cross-context behavioral advertising across multiple websites. You can opt out of this sharing by configuring your web browser to send us an opt-out preference signal, or by downloading a browser extension that can be enabled to support your single opt-out preference signal. We process opt-out preference signals in a frictionless manner. Your opt-out signal will apply to your device's browser.
